Terms and Conditions

A deposit of \$400 is required to reserve your wedding date. The balance is due in full 2 weeks before the wedding date. A \$25 fee will be charged for all returned checks. Upon your signature, Blue Pearl Productions reserves the time and date agreed upon, and will not make other reservations for this time and date. For this reason, all deposits are non-refundable if the wedding is cancelled for any reason, or if the date is changed. If we are unable to perform the services agreed upon for whatever reason, we will refund your deposit. We reserve the right to assign any videographer(s) for this assignment. It is the responsibility of the client to secure permission of church, synagogue or other officials to videotape the ceremony. The deposit is non-refundable if such officials prevent videotaping. Blue Pearl Productions will abide by the rules of the church or synagogue regarding camera placement at the ceremony. Permission of the Officiate is required before the camera(s) are set up. It is understood that Blue Pearl is the exclusive official videographer and others taking videos will be permitted only at our discretion. Blue Pearl takes utmost care with respect to the exposure, editing, duplication and delivery of the video products and services offered. However, in the event Blue Pearl fails to comply with the terms of this contract due to any event or act outside of our control, our liability is limited to the refund of the deposits. It is understood and agreed that Blue Pearl cannot guarantee to produce any video product of any specific object(s), situation(s), person(s), or event(s) or in combination thereof, taken by Blue Pearl in the performance of the duties and/or services specified in this assignment. Client agrees to entrust all editing decisions to the experience and creativity of Blue Pearl. A post production fee of \$70 per hour may be applied to any changes. A minimum \$25 per hour travel fee may be added for weddings outside the San Diego Metropolitan service area. Blue Pearl reserves the right to use portions of the videotape for promotional or other purposes. All rates are subject to 7.25% tax. Your final edited videos will be ready approximately 6-12 weeks following the wedding (or more depending upon our backlog). **Important** Our DVD discs are recorded in the new DVD-R standard 2.0 format, which is different than commercial DVDs. Some older DVD players are not compatible with this format. However, almost all models manufactured after November 1999 are compatible. We have found that Toshiba and Phillips to be the least compatible. It is the responsibility of the buyer to have a compatible player. We can only guarantee properly recorded discs without errors.
